Community’s View Of Research Ethics And An HIV/AIDS Clinical Trial In Uganda

(Kearsley A. Stewart, Northwestern University)

Based on 100 individual interviews and 12 focus group discussions conducted in Uganda in 2002 and 2004, this paper analyzes local definitions of western-derived concepts of bioethics, such as autonomy, beneficence, risk, and ethics, in the context of HIV/AIDS research in Uganda. The paper asks two broad questions: (1) How can we translate these Euro-American concepts into everyday language and research practice in Africa? (2) Given the difficulties of achieving #1, is it even possible to conduct ethically-sound clinical trial research in a resource-poor community in Africa? Recommendations for improving the conduct of health research are discussed.

The “HapMap” Project in Nigeria: Community Consultation, Individual Consent, and Social Justice

The haplotype map (HapMap) is viewed as the next step in expanding our knowledge of the human genome. DNA samples are being collected from geographically diverse communities throughout the world. This paper reports on community engagement prior to DNA sampling in Nigeria. Strategies included establishing a community advisory board, key informant interviews, focus groups, a survey, and town meetings. Despite this robust approach to community consultation, how “informed” and voluntary is research participation in light of community approval for the study? A number of challenges arise, including comprehension and its influence on individual choice and issues related to capacity building and social justice.

Disclosure of HIV Status to Children: Developing Culturally Appropriate Guidelines

Regulatory agencies require informed assent from children participating in domestic and international biomedical research. Obtaining informed assent from children participating in AIDS research, however, is complicated in developing countries where most children are unaware of their HIV status. Moreover, few recommendations exist on how and when HIV status should be communicated to children. We present an approach using quantitative and qualitative methods to develop culturally appropriate assent and disclosure guidelines and to create effective social support systems for families choosing to disclose as part of AIDS research in Kinshasa, Democratic Republic of Congo.

Session abstract:

Over the past two years the Society for Medical Anthropology (SMA) Task Force on Clinical Trials has presented overviews of the ethical challenges associated with the expansion of clinical research in developing countries. We outlined contributions that anthropologists can make toward enhancing ethics, protecting vulnerable populations from exploitation, and supporting research that is likely to improve health in resource-poor settings. In this session, sponsored by the SMA, we present results from several projects that highlight recent anthropological contributions to the ethics of clinical research, as well as lessons learned and the on-going challenges associated with this work.

Oh! That’s What You Mean By Ethics?: A Rural



Cross-Cultural Perspectives on Autonomy and Decision-Making about Research Participation

Internationally accepted bioethics principals include recognition of autonomy in decision-making about research participation. However, in many countries, enrolment of women in research without informing their male partners is considered a violation of cultural norms. This is especially salient in studies requiring changes in sexual behavior. We present findings providing a range of views on participation in microbicides research, including data from community leaders, health providers, and female and male potential research participants in seven countries. Findings have been used to develop an approach to support participants' decision-making that is culturally appropriate, yet supports the principal of respect for persons.

Who Speaks For The Community In International Clinical Trials?

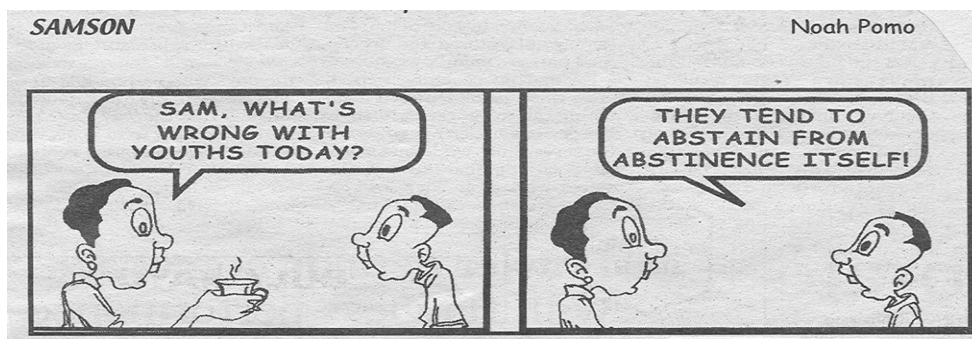
In recent years ethics guidelines for the conduct of international clinical trials have included calls for greater community participation in the design and implementation of trials. A variety of models have emerged for responding to this call, along with critiques of those models. Efforts to make clinical research more participatory run up against divergent uses of the term "community" by various stakeholders, including bioethicists, researchers, trial participants, and activists. The nontrivial implications of divergent definitions are illustrated through the example of multinational trials testing the use of an antiretroviral to prevent HIV infection.

Condom Beliefs in Zimbabwe

Zimbabwe is a southern African country with a population of approximately 11.6 million. The number of adults living with HIV/AIDS at the end of 2003 was estimated to be around 25%. HIV/AIDS awareness and prevention messages generally promote the use of condoms. This paper is about what some Zimbabweans think about the condom. The findings are based mainly on interviews from January to December 2003 which I did in Nkulumane Township in Bulawayo, as well as some data from a survey questionnaire administered to a random sample of residents in one ward of the Township.

First I will speak about the positive condom beliefs that I encountered. A large section of the township appears to accept condoms as a helpful tool to prevent infection. They generally doubt that abstinence is a possible choice particularly for the youth and encourage the use of condoms. The following cartoon humorously refers to this.



Therefore, numerable informants strongly believe that it is necessary to at least make condoms available. Informants are also aware of the need to use a condom within marriage because men who are thought to be generally promiscuous may be or are indeed already infected and may infect their wives. Overall, while accepting the minimal risks for contracting HIV remaining with the use of condoms, this section of the population approves the condom: "When asked about what is better, to use or not to use a condom, my answer is clear: to use it, because it protects... You can enjoy the encounter because you do not have to be afraid of this disease." In other words, prevention campaigns have been successful with this section of Township residents.

However, a sizable number of residents does not agree with these positive views about the condom and is critical at best or entirely hostile at worst. For example some said that "the condom is like someone telling you to walk on thorns and promises to bandage your wounds afterwards". For them, sex in times of HIV/AIDS can hurt like walking on thorns. And although the condom promises to be helpful when someone gets hurt, this is only a false promise and condom use could actually result in HIV infection. The following statement reiterates this view: "When we listen to the radio, we hear that those who use condoms are the ones who are HIV negative. But when we hear of the results of testing, then we realize that those who use condoms are actually HIV positive." The reasons given why HIV infection happens despite or even because of condoms can be grouped into four categories of beliefs.

The first category of condom beliefs could be called 'popular science'. Particularly churches opposed to the use of condoms spread messages about the minimal risk remaining with proper condom use. They frequently exchange 'minimal risk' with 'major risk' referring to an unreliability of condoms. They do so because their main focus in HIV/AIDS prevention is abstinence. In discussions many use and develop these arguments:

“Condoms have pores, as it is scientifically proven. Everything has got pores, even our skin has pores. The HIV virus is so small that it can enter through these pores in the condoms.” I was surprised how interested particularly the young are in anything that appears to be scientific and how quickly they absorb it. It seems to me that many HIV/AIDS campaigners do not address this interest sufficiently and indirectly lead people into the hands of pseudo-scientific ideologies.

Besides the issue of the holes, it is often argued that the poor quality of condoms results in a high risk for contracting HIV. A science student argues that this is because like other donations from overseas “also condoms that are donated to Africa are of poor quality.” Newspaper reports on shipments from overseas of faulty condoms reinforce such suspicions. Generally one also hears arguments like the following: “Most of the condoms are not produced locally but come from outside the country. It takes a long time to ship them to Zimbabwe. They need also to be stored in a cool place. They are brought by ship in metal containers which can get very hot in the sun. When you heat up a plastic it expands and also the holes it naturally has expanded.” The perception that Africa is the dumping ground for old goods from Europe and America, the distance from these places of production and economic prosperity, and the lack of proper facilities in Zimbabwe to store them, is behind such views. Condom beliefs do not escape being shaped by negative perceptions about the global and the local economy. After all they are a product of these economies.

The reliability of testing the quality of condoms is also in doubt. The following statement of a young man echoes what many voiced: “From let’s say 500,000 condoms they only test 10 and 499,990 are not tested and they tell us that it is 99% reliable. They test only ten and give the rest to people! How do they know it! It could happen that 499,990 people who used these condoms are now HIV positive!” The young man obviously misunderstood what testing means and how conclusions are drawn. Perhaps better explanations on this commonly misunderstood issue would help people to base their decision to use or not to use condoms on better information! Keeping this and the quality issue in mind as well as thoughts about the holes in the condom, it is not surprising that a large section of a random sample of the Township population doubts the reliability of condoms.

The second category of condom beliefs is conspiracy theories on three levels: (1) the individual, (2) the economic, and (3) the political level. On the individual level the suspicion is raised that those who are HIV positive deliberately spread the disease. Due to the unavailability of antiretroviral drugs and the unaffordability of health care, being HIV positive in Zimbabwe is generally coterminous with a death sentence. The fear that HIV positive individuals become angry, resentful, and even vengeful seems logical to many Zimbabweans; HIV positive people are often thought to plot to deliberately infecting others with HIV. There are a large number of people in the random sample that hold this perception. Even condoms

may be part of their malicious plot: “They know that they have AIDS and want to kill others. Before they use a condom they pierce it. Therefore it is necessary that the woman is ‘dressing’ the man with the condom and vice versa, so that we know for sure that this did not happen. When you sleep together and your partner starts touching the condom you get suspicious.” However, this fear becomes very remote with the few HIV positive individuals who are in the position to receive antiretroviral treatment. They have a different attitude: they appear to live responsibly, have hope and see a future. It is difficult to imagine them to wanting to kill others. It is possible that providing antiretroviral drugs on a larger scale would reduce this fear related to the use of the condom.

On an economic level of conspiracy, a suspicion is raised that condoms are promoted not because they are a reliable tool but because someone wants to get rich through condom sales. A young man’s statement reiterates what many told me: “The condom is just for business. The reason to promote condoms is just to make money.” Also a common conflation of prevention messages with commercial adverts feeds into such perceptions. A young man told me, that “when you see an advert on TV about a certain product, for example a soft drink, then this advert creates a desire in you and you want to taste it. The same happens with the adverts about condoms. So, they want to taste how that thing works and obviously, you can only taste it on someone of the opposite sex!” Generally, people do not distinguish informative ads from commercial ads. For them it is just a promotion for something which someone wants to sell, to get money, and to get rich! The logic of being used by the economically powerful is related to the economic situation in Zimbabwe: the unemployment is around 80%, salaries are low and the cost of living is rising. Most are gliding into poverty but at the same time see that there are still someone enjoy a high living standard: usually the business men. Condom perceptions do not escape perceptions of those at the bottom of the economy. It is possible that future disentanglement of condom ads from commercial ads would at least minimize such negative perceptions.

On the political level of conspiracy, many relate HIV/AIDS to a suspicion about outsiders with a malicious intent: “It surprises me that AIDS has not been a problem during Smith’s [last prime minister of the white minority government] era. But after independence we have heard suddenly of condoms and family planning. I am convinced that some white politicians use these to kill blacks so that they can get back the country.” Very widespread is the following belief that HIV has been deliberately planted into the lubrication of condoms by such malicious agency: “When you pour hot water into the condom and you leave it for some time then germs develop. You will see it full of tiny worms.” A sizeable group within the random sample, around 11%, expresses belief in this myth. This condom belief is reminiscent of common theories about the origin and the genesis of HIV/AIDS as a tool in the hands of Western racists to eradicate Blacks and at times referred to in current political propaganda. If politicians would refrain from using such propaganda, it could also positively impact on condom beliefs.

The third category of condom beliefs is related to moral connotations. Many respondents told me: “We are told to use condoms in order to be protected. It is like telling us that we should just enjoy with many sexual partners.” Such views result in a heavy stigmatization of the condom: only promiscuous people use them, particularly the prostitutes, but between partners who trust and are expected to be faithful to each other they have no place. The following two cartoons from local newspapers refer to such beliefs.



The strong connotation of condoms with promiscuity leads often to the equation that condoms must be also promoting HIV/AIDS because the promiscuous are the ones contracting the virus. Several told me: “You see they have been promoting condoms, that is how they are promoting AIDS! We realize that our children are dying because of the condoms. The condoms are killing our children.” This sentiment perhaps is echoed in the following cartoon [IMAGE 4]. “Wearing” condoms is not smart; it is actually stupid because you are at a higher risk of contracting AIDS. The belief that condoms promote promiscuity is very common: more than 62% within the random sample held this belief.



As morals are generally based on belief systems, the condom becomes for some a symbol of the antichrist, of Satan and as a tool in his hands. The ‘condom-religion’ stands even in direct opposition to the ‘God-religion’, conflicting with religious concepts such as the ‘Kingdom of God’ and the ‘Word of God’: “Let’s Kingdomise and not Condomise” and “The only condom is the Word of God.” Instead of ‘believing’ in the ‘condom’ people should ‘believe’ in the ‘rosary’ as some argue. The placing of condoms and faith on a single level defines them as competing worldviews with opposed values. This may be partly because of different approaches; NGOs and government agencies often acknowledge the reality of sexual behavior and tell people to at least protect themselves. In contrast, many churches focus on behavioral change and tell people to abstain. This antagonism is also indicative of a lack of cooperation between different groups. Overall, I got the impression that there is a mutual mistrust and belittling between the groups.

The fourth category is related to an indigenous concept of the sexual intercourse. Particularly healers and elderly told me that during intercourse man and wife are ejaculating into each other body-fluids while at the same time actively drawing the body-fluid of the other into one’s own body. Therefore, some expressed the fear that the condom might be sucked into the female body and cause illness. However, the main concern was the lubricant of the condom. When a condom is used the lubricant inside the condom is thought to be drawn into the male body and the lubricant outside the condoms thought to be drawn into the female body. There is then a fear that the lubricant may cause illness, even AIDS. In this belief it is dangerous or even lethal to use condoms. Dialogue with healers and elders about the nature of lubricants in the condoms and their effect on the human body would perhaps convince them and their clientele that the lubricant is safe and even if drawn into the body harmless.

I conclude with a general statement of respondents: “Condoms have an illness and lead many to the graves.” Some people take it quite literal and argue that HIV is in the condom or that the lubricant of the condom causes illness or even AIDS. Others say so because they do not believe in the quality and efficacy of condoms out of some reason; therefore condoms ‘have an illness’ because they are indirectly responsible for AIDS. Again others relate the condom to promiscuity and therefore to high risk behavior for acquiring HIV. The condom is again indirectly responsible for AIDS. The negative condom beliefs are partly based on misunderstandings but mainly on perceptions about the local and the global economy, on political propaganda, on the unavailability of treatment, and on the lack of communication among different players in the field of HIV/AIDS awareness and prevention. Some issues are beyond our control, while others could be addressed as indicated in this paper. (The images are all taken from the Zimbabwean newspaper, The Daily News.)
