## Anthropology 217 **Discourse and/of the Body**

Mondays, 4:00-6:00PM 115 Kroeber Hall

This course explores relationships between discourse analysis, broadly defined, and approaches to health, biomedicine, and biopolitics. It queries how presupposed notions of language, communication, narrative, media, and the like provide implicit foundations for producing and naturalizing notions of health, disease, medicine, and the body and their associated practices and materialities—and vice-versa. The goal is to reread classic and recent readings in linguistic and medical anthropology and other fields in such a way as to unsettle established approaches and collectively forge new ways of thinking and writing. The course aspires to create a project enacted in both "why not" and "what if" modes, identifying the forms of boundary-work that has impeded critical thinking across these domains and conjuring the outlines of new approaches.

## Requirements

1. Careful preparation of readings for class.

2. Active participation in seminar meetings.

3. A one-page prospectus for the research paper, due 11 March. Students are urged to come in and speak with me as soon as possible in shaping the project.

4. A research project, resulting in an approx. 25 pp. (double-spaced) research paper, due on Monday, 13 May 2018, that a) develops an approach relating to critical understandings of discourse and health/disease/healthcare, b) applies it to a problem relevant to your own research, and c) uses as many of the course readings as are relevant. A way of thinking of the assignment is to imagine that your paper will form a chapter in an edited volume that is meant to map this new project; what would the perspectives you bring and the object(s) you choose contribute? Please submit electronically.
