Anthropology 205 B: Medical Anthropology Theory Winter 2021 Wednesdays, 10 am-1 pm

This course looks at current trajectories in medical anthropology theory. By reading texts that have informed these trajectories, both within anthropology and in related fields, we will attempt a rich approach to where theory in medical anthropology has been and where it might be going. This will entail moving outside of the clinic and the lab to the formation of subjectivities, the religious/secular distinction, and the way institutions makes violence and health inextricable. We will attend to key moments in structuralist and poststructuralist approaches—e.g., Foucault on disciplinarity and life; Lacan on subject formations; critical race theory on the figure of man—that have helped shape contemporary approaches. We will look to the ways anthropologists have taken up, played with, or fought with these intellectual currents through ethnographic work in 'the field.' How is truth produced: what configurations are needed to give authority to particular conceptualizations of life, ethics, personhood? How are people constituted for care and violence? How have anthropologists explored the constitution of trauma and memory? How do we define the good, the human, and the inhuman? How do institutions enact discipline and nurturance in the same moment? This exploration will include interrogating current critical moves in medical anthropology, including the critique of humanitarianism, the way violence signifies, and the law as site of subjectivity. In the course as a whole, we follow trajectories in medical anthropology that offer new insights into institutional configurations, cultural meaning, and subject positions in today's ethnographic moment.

## **Requirements:**

In addition to regular attendance and participation every week, students will rotate leading a discussion about the week's readings in pairs. A weekly précis on the readings will be due before each class. One paper on the readings will be required, no more than 15 pgs. Each précis and the final paper are to be emailed to Rachel and Ian by 7pm the night before the class where we discuss those readings.
